

TERMS OF SERVICE FOR CODEGYM UNIVERSITY ONLINE COURSES

1. OVERVIEW

The CodeGym University courses are provided by HiTech Rush Inc ("CodeGym University," "we," or "us"). By visiting our site and/or purchasing something from us, you engage in our "Service." You agree to be bound by the following terms and conditions ("Terms of Service," "Terms") and our general Privacy Policy, [available by this hyperlink](#).

These Terms of Service apply and policies referenced herein to users of the site who enquire about or purchase one of the following online learning courses under the concept of CodeGym University: "Java Developer Profession," "Java Fundamentals," and "Android App Development for Beginners."

Please read these Terms of Service before accessing or using the courses mentioned above. By accessing or using, you agree to follow these Terms of Service.

Any new features or courses which are added to the CodeGym University service portfolio shall also be subject to the Terms of Service. We reserve the right but are not obligated to limit the sales of our products or Services to any person, geographic region, or jurisdiction. We may exercise this right on a case-by-case basis.



All descriptions, features, and pricing of the Services are subject to change at any time without notice, at our sole discretion. We reserve our right to discontinue any Service at any time.

3. COURSE-SPECIFIC CONDITIONS

3.1 JAVA DEVELOPER PROFESSION COURSE [FOR USERS FROM INDIA]

Terms of the Subscription, which includes the option to participate in the program “Java Developer Profession” for Users from India:

1. The User is eligible to participate in the course program without a regular CodeGym subscription. After the Customer makes a payment for 1, 6, or 12 months of participation in the “Java Developer Profession” course, CodeGym activates a subscription with access to CodeGym online course for the paid training period within the course program.
2. Access to online classes with Mentors is provided upon the User's prior payment (prepayment) for the participation in the course: full payment (for 12 months) or partial payment for 1 or 6 months.
3. The User is eligible to contact the Mentors personally about advisory materials and Java technologies studied throughout the 12-month “Java Developer Profession” course, submit their task solutions for verification by Mentor, and receive comments and recommendations on their solutions.
4. Participation in the “Java Developer Profession” course is one-time, subject to the availability of payment for participation.
5. Course materials are provided directly during the course. They cannot be issued to the User at his request in case of refusal to participate in the “Java Developer Profession” course program.
6. The certificate of completion is provided to Users (course students) who abided the following rules:
 - attended every live session of the course
 - completed the final projects of each module before the deadline
 - passed the final exam

3.2 JAVA FUNDAMENTALS COURSE

Terms of the Subscription, which includes the option to participate in the program “Java Fundamentals”:



1. The User is eligible to participate in the course program without a regular CodeGym subscription. After the Customer makes a payment for 1 month of participation or for the whole period (4 months) of participation in the “Java Fundamentals” course, CodeGym activates a subscription with access to CodeGym online course for the paid training period within the course program.
2. Access to online classes with Mentors is provided upon the User's prior payment (prepayment) for the participation in the course: full payment (for 4 months) or partial payment for 1 month.
3. The User is eligible to contact the Mentors personally about advisory materials and Java technologies studied throughout the 4-month “Java Fundamentals” course, submit their task solutions for verification by Mentor, and receive comments and recommendations on their solutions.
4. Participation in the “Java Fundamentals” course is one-time, subject to the availability of payment for participation.
5. Course materials are provided directly during the course. They cannot be issued to the User at his request in case of refusal to participate in the “Java Fundamentals” course program.
6. The certificate of completion is provided to Users (course students) who abided the following rules:
 - attended the live sessions of the course in Module 1 and Module 2 of the Course Curriculum
 - completed the Final Project (Module 3) before the deadline

3.3 ANDROID APP DEVELOPMENT FOR BEGINNERS

Terms of the Subscription, which includes the option to participate in the program “Android App Development for Beginners”:

1. The User is eligible to participate in the course program without a regular CodeGym subscription. After the Customer makes a payment for 1 month of participation or for the whole period (3 months) of participation in the “Android App Development for Beginners” course, CodeGym activates a subscription with access to CodeGym online course for the paid training period within the course program.
2. Access to online classes with Mentor is possible only if the User has paid in advance for participation in the course: full payment (for 3 months) or partial payment for 1 month.
3. The User is eligible to contact the Mentor personally about advisory materials and Android development technologies studied throughout the 3-month



“Android App Development for Beginners” course, submit their projects for verification from Mentor, and receive comments and advice on their solutions.

4. Participation in the “Android App Development for Beginners” course is one-time, subject to the availability of payment for participation.
5. Course materials are provided directly during the course. They cannot be issued to the User at his request in case of refusal to participate in the “Android App Development for Beginners” course program.
6. The certificate of completion is provided to Users (course students) who abided the following rules:
 - attended the live sessions of the course
 - completed four practical projects before the deadline

4. ADDITIONAL TOOLS AND PLATFORMS

During the course in which you’ve enrolled, we may provide you with access to third-party tools (for communication with a mentor or conducting live training sessions) over which we neither monitor nor have any control nor input.

Any use by you of optional tools offered through the site is entirely at your own risk and discretion. You should ensure that you are familiar with and approve of the terms on which these tools are provided by the relevant third-party provider(s).

In the future, we may also offer new services and features through the website or advise you on additional tools. Those features and tools shall also be subject to these Terms of Service.

5. REGULATION OF USERS’ PERSONAL INFORMATION

6. TERMINATION
